Products: through a diverse range of product lines, including OTCs, shares, futures and options on futures



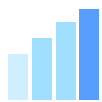
Devices: through best-in-class technology, with over 87% of all customer OTC trades on mobile or tablet devices in FY 2023

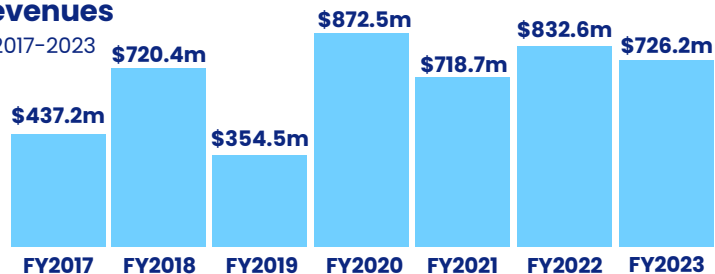

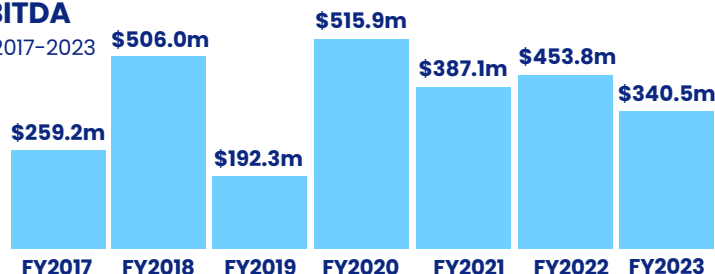
Revenues

FY2017-2023



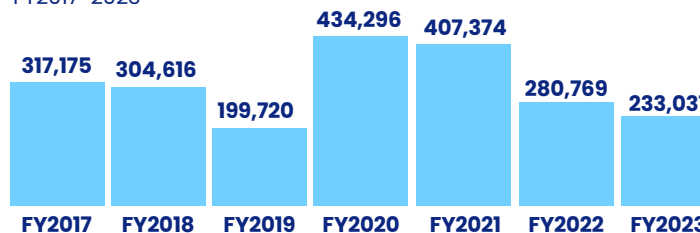
EBITDA

FY2017-2023



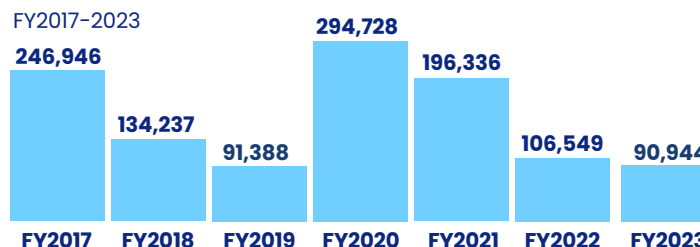
Active customers
